### **EPNS Fellowship 2015**

The EPNS is thrilled to have awarded 2 EPNS Fellowships. We will be re-opening the opportunity to apply for a Fellowship in the next few weeks, so watch this space.

Congratulations and best wishes to the following:

- **Dr Monika Kukuruzović from Croatia who will be spending the Fellowship in the UK.**

I have always had an interest in child neurology and ever since my formal Pediatrics residency ended in January 2012, I became a formal member of Child neurology team at our Clinic. Working and gaining experience in child neurology gave me opportunities for publishing papers and actively participating in congresses and symposiums in Croatia and abroad. In my desire to broaden the scope of my education I have been enrolled in PhD program since September 2012 and have been working on a thesis titled: Association between types of epilepsy with polymorphism of ApoE genotype in children. It is my goal to improve care pathway so as to identify children with drug resistant epilepsy more quickly and in particular those likely to benefit from surgical intervention. For children too young to have surgery in Croatia. I would like to develop an algorithm by which we could completely evaluate children with drug resistant epilepsy. I should learn the ingredients of effective pre-operative assessment, when to use rarer investigational resources such as fMRI or PET in a cost-efficient way and how to manage the peri- and post-operative care pathway. This opportunity will greatly improve my approach to children with epilepsy and significantly enhance and enrich our whole child neurology team. Therefore, it is my great privilege to be given this opportunity and I would like to thank you for recognizing the value in my goals!

- **Dr Diana Barca from Romania who will be spending the Fellowship in Belgium.**

My name is Diana Barca and since 2009 I am a pediatric neurologist, part of the team in Bucharest. Working in the largest Pediatric Neurology University Clinic gave me the opportunity to gain experience in this field, but also to define the difficulties of diagnostic in certain pathologies. Working close with neonatal units and being part of developmental monitoring of premature and full term born babies allowed a large screening of this population and oriented my interests in metabolic etiology first in this age group and later in older children. Since availability for testing in this area is limited in Romania (including limited neonatal screening for metabolic disorders), I consider crucial improving my clinical skills in order to be able to offer a better care and mainly to develop pattern-recognition and diagnostic algorithms. This would further enable me to share the experience with my colleagues, fulfilling the need for an early diagnosis and targeted management of these cases in our clinic. Also it would limit the need for referral abroad, thus shortening the intervention time and also allowing the families with financial difficulties to benefit from the same level of healthcare. Therefore it is my great privilege to be given this opportunity and I would like to thank you for recognizing the importance in my goals!
