On behalf of the EPNS Scientific & Research Committee, I am delighted to reflect on the success of our 16th EPNS Congress in Munich. With around 2,000 delegates registered, the Congress exceeded expectations and provided an inspiring platform for learning,

Don't forget to mark your calendars for the 17th EPNS Congress, taking place on 6–10 April 2027 in Barcelona. I would also like to extend my congratulations to the Stockholm team for their successful bid to host the 18th EPNS Congress from 11–15 September 2029.

The EPNS Scientific & Research Committee attention is now on the next EPNS Research Meeting taking place in Thessaloniki on 16-17 October 2026 where experienced professionals and young researchers in the field of Pediatric Neurology will get together for interactive discussions around the presented topics. I hope to see you there!

Through our EPNS Education & Training Committee during 2025, the EPNS continued to support professional development and training across Europe and beyond, with the 2nd EPNS Exam in Munich, completing the latest cycle of its three-year training programme in Ferrara, and supporting the biennial Central Eurasia Workshop in Almaty. Accessible, digital learning remained a priority, with regular webinars and the EPNS Moodle providing ongoing educational opportunities. The Society was also honoured to facilitate the EPNS Fellowships and Visiting Teacher programmes, offering life-changing professional experiences for members.

I hope you will be able to get involved in our planned educational activities for 2026, which include the 3rd and last round of EPNS Training Courses in Ferrara, with the topics 'Neonatal Neurology' and 'Genetics for Paediatric Neurologists'. The EPNS Biennial Caucasus Teaching Course on 'Acute Neurology' will be in Tbilisi. Not forgetting the opportunity for EPNS Fellowships, Visiting Teachers, the EPNS supporting educational events, and of course our ongoing highly respected EPNS webinar programme.

The EPNS Advocacy & Collaboration Committee has had another highly productive year in 2025, strengthening our role as a global advocate for child neurology and brain health. The committee successfully completed its first four-year term, expanded our network of 44 IGAP representatives across Europe, and delivered a series of advocacy training webinars, concluding with a session at the EPNS Congress in Munich. Our collaborations with key organisations—including the World Health Organisation (WHO), European Brain Council (EBC), OneNeurology, European Academy of Neurology (EAN), European Academy of Childhood Disability (EACD), European Academy of Paediatrics (EAP), European Reference Networks (ERNs), European Medicines Agency (EMA), and international child neurology societies—have reinforced the EPNS's voice in policy, research, and education at European and global levels. Highlights include active participation in Brain Health initiatives, joint projects with the Young EPNS on sustainability, and new Memoranda of Understanding with the International League Against Epilepsy (ILAE) and International Paediatric Stroke Organisation (IPSO). I am deeply grateful to all EPNS members and partners for their dedication and commitment, and I look forward to 2026 with continued success and vision.



The Young EPNS (YEPNS) continues to be a dynamic and integral part of the EPNS. Their energy, creativity, and dedication play a crucial role in advancing the Society's mission, and I am proud of the meaningful contributions they make across education, advocacy, and innovation. I look forward to building on these achievements in the year ahead. More details can be found in the YEPNS update later in this report.

With representatives from nearly all European national Paediatric Neurology associations, the Committee of National Training Advisers (CNA) is a vital network supporting key EPNS initiatives such as the IGAP initiative. A summary of their activities is included later in this annual report, together with a report about the Training Advisory Board (TAB) which offers national child neurology societies the opportunity to evaluate their national training system.

EPNS Scientific and Research Committee

In 2025, we were proud to host the 16th EPNS Congress in Munich, Germany—an event that reinforced our mission to advance paediatric neurology. Over 3.5 days, the Congress offered, besides its wonderful scientific content, high-quality educational sessions and networking opportunities. The EPNS contributed financial support, including the EPNS Academy on the last day of the Congress plus offering 20 bursaries to help broaden participation.

EPNS Education and Training Committee

During the EPNS Congress mentioned above, the EPNS subsidised the 2nd EPNS Exam. The EPNS also continued to deliver its established 3-year training programme, which concluded its latest cycle in Ferrara, Italy. In addition, the Society provided support for the biennial Central Eurasia Workshop in Almaty, Kazakhstan. Investment in digital learning remained a priority, with the EPNS Moodle and online platforms used for Webinars taking place approx. once a week. The EPNS was also honoured to have once again funded the EPNS Fellowships and Visiting Teacher programmes, enabling truly life-changing professional opportunities.

EPNS Advocacy and Collaboration Committee

This committee has continued to raise the profile and influence of child neurology on national, European, and global stages. By maintaining full membership in the European Brain Council (EBC), the EPNS gains direct access to a leading advocate for the prevention, early diagnosis, and treatment of brain disorders, while helping to position brain research as a societal priority. Through this network, the EPNS is championing a life-course approach to brain health—supporting development from the antenatal period, through childhood and adolescence, and into later life—ensuring that neurological health remains a priority at every stage.



EPNS Guidelines Committee

The committee continued its work with partner organisations on guideline development in areas such as paediatric epilepsy and transitional care. Although no expenditure was required in 2025, an annual budget remains allocated in accordance with contractual obligations.

EPNS Membership, PR and Website Committee

Membership continues to grow steadily, reflecting the sustained engagement of our community. A modest budget is reserved for communication and promotional activities.

EPNS Finance Committee

We remain committed to managing administrative costs carefully while ensuring the effective support of all EPNS activities.

I am pleased to confirm that the Society remains in a secure financial position, with adequate resources held safely in our account at a Private Bank in Germany.

As I conclude my term on the EPNS Board, I would like to express my sincere gratitude for the support, dedication, and collaboration shown by colleagues, members, and partners throughout these years. It has been an honour to serve. I extend my warmest wishes to all of you and every success to my successors as they take on this important role.

16th EPNS Congress 2025

The 16th EPNS Congress took place at the ICM – International Congress Center Munich, Germany on 8-12 July 2025, hosted by the Gesellschaft für Neuropädiatrie (GNP).

The Pre-Congress Symposium took place on 8 July 2025 with the title 'The Child and the Brain. Where it's all started. Hosted by the GNP, it was a full packed day offering an exclusive deep dive into paediatric neurology's past, present, and future. Held at the state-of-the-art BrainLab in Munich, this interactive event combined clinical examination, neuroimaging, neuromodulation, AI, gene therapy, and philosophy in an engaging format.



The EPNS Congress



The Congress theme classified the field of Child Neurology into 'A for acute, B for Brain, Health & Science and C for Chronic', building our own alphabet of caring and research dedicated to children.

The programme was developed with innovative platform sessions and distinguished invited speakers.

A total of 12 Early Morning Sessions, 5 Plenary sessions, 20 parallel sessions and 15 guided poster walks gave plenty of room to learn and discuss about current standards of care and a width of research activities.

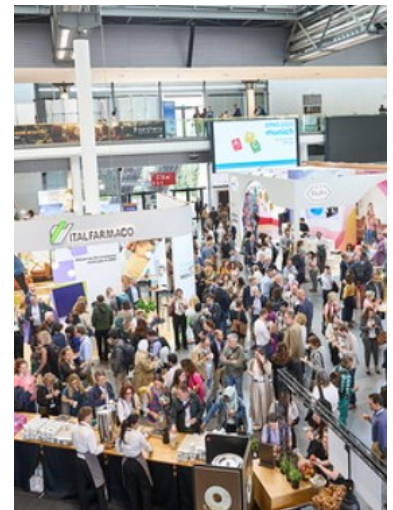
An EPNS record breaking 922 abstracts were submitted, 140 of which were accepted as oral abstracts, 105 moderated posters with short presentations and 662 eposters were shown at Terminals through the event.



With more than 1,943 participants, excluding exhibitors, the Congress surpassed all expectations.



The Congress was opened with a ceremony and presentation of best abstract and best paper award and the flagship Aicardi Award Lecture, three full days of educational sessions, a new Skills Lab organised by the GNP, networking, interaction, updates from our industry partners, and the EPNS Academy & Highlights on Disorders of Speech development as a grand finale.

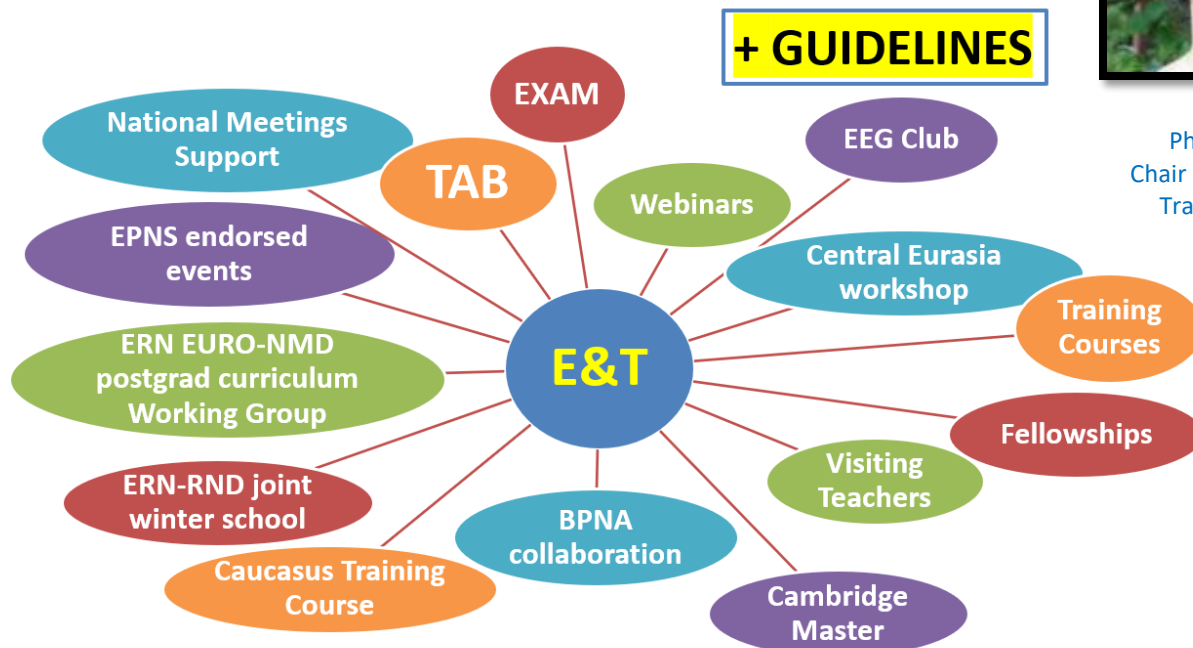

The Moodle

EPNS Exam

After a successful first summative EPNS Exam in Prague in 2023, our 2nd EPNS Exam took place on 8 July 2025 at the EPNS Congress in Munich. The CNA contribute to the exam question development, with the EPNS Exam assessing the basic knowledge needed to underpin Paediatric Neurology training. Achieving a pass in the EPNS Exam is an excellent personal goal in this area of specialised medicine. Candidates wanting to test their knowledge, including those in countries without a nationally recognised exit exam, will find it very helpful. Plans will soon be underway for the next EPNS Exam which will take place at the next EPNS Congress in Barcelona in April 2027.



“With the generous support of the EPNS Visiting Teacher Programme, we held a three-day teaching conference titled “From Genetic Testing to Targeted Disease Management in Pediatric

Epilepsies”. The event welcomed around 30 participants, including pediatric neurologists, residents, and medical students, and created a lively space for learning, sharing, and exchanging ideas”

EPNS Visiting Teacher Manoëlle Kossorotoff visited Romania 9 – 11 October 2025

This visit came as a natural follow-up after the EPNS fellowship won by Raluca Tudorache who worked in a vascular – stroke unit in Necker Paris under supervision of MK. With the intention of returning in Romania and developing a pilot stroke thrombolysis unit in Bucharest Romania, the Romanian Pediatric Neurology Society invited MK to coach the Romanian team. A group of practical discussions were organized together with the Neurology colleagues in the Obregia Center of Expertise of Rare Pediatric Neurology Disorders. 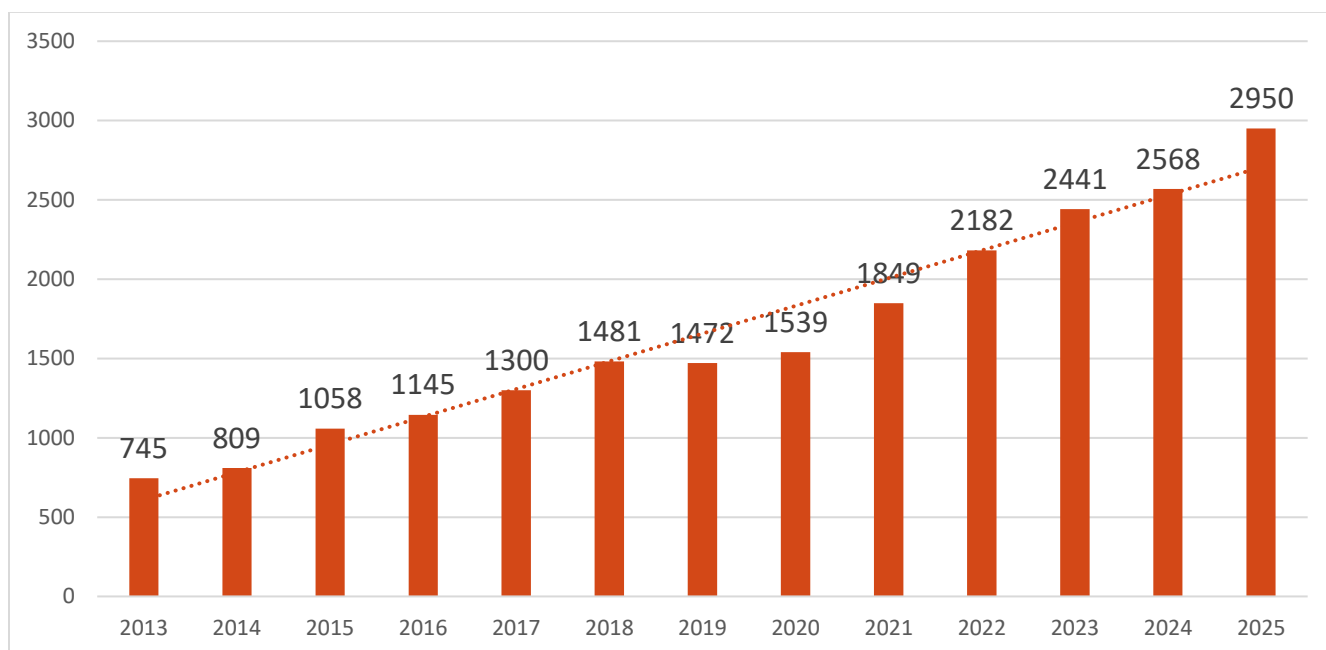

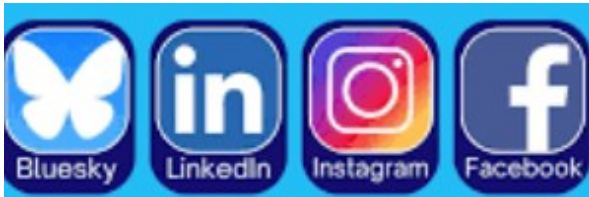
Promoting the EPNS

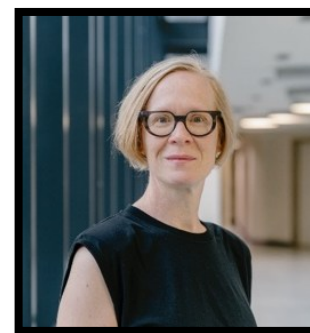

Intersectoral Global Action Plan on epilepsy and other neurological disorders (IGAP)

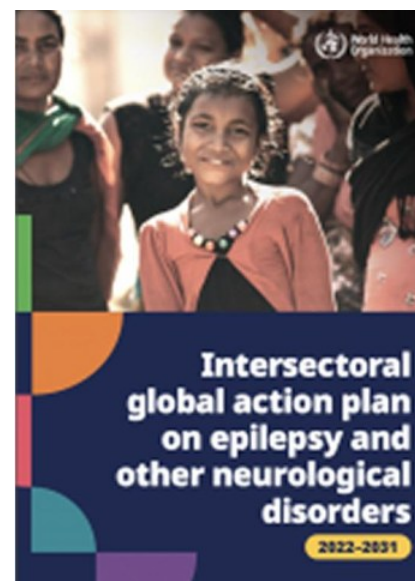
The World Health Organisation's IGAP (Intersectoral Global Action Plan on Epilepsy and Other Neurological Disorders, 2022–2031) aims to improve access to treatment and care, enhance quality of life, and promote brain health across the life course.

This has been the driving focus of the EPNS Advocacy & Collaboration Committee.

We are honoured to have appointed 44 volunteer EPNS IGAP representatives, one person in each country across Europe, and they continue to play a crucial role in advocating for implementation at the national level, and I express my thanks for their contributions:

World Health Organisation

EPNS welcomed the release of the World Health Organisation's Global Status Report on Neurology, a groundbreaking call to action to address the growing burden of neurological disorders and promote brain health for all. This landmark publication presents the first-ever global baseline assessment under the *Intersectoral Global Action Plan on Epilepsy and Other Neurological Disorders 2022–2031 (IGAP)*. Drawing on data from 102 WHO Member States, representing 71% of the world's population, the report establishes 2022 baseline values for IGAP's 10 global targets. It identifies critical gaps, barriers, and inequities, and provides data-driven, actionable recommendations to help

countries advance neurological care and achieve IGAP's strategic objectives.

This marks the official launch of our EPNS journey toward a greener, more equitable future in paediatric neurology, aiming to make a real and lasting impact on health, equity, and the planet. Moving forward, the EPNS will be appointing an EPNS Board member to champion a broad vision of sustainability — integrating environmental responsibility, equity, diversity, inclusion, and social accountability into the Society's core functions. It would be an overarching role and report to the full EPNS Board – not one dedicated committee with the following key responsibilities. We look forward to sharing more news about this role as it evolves.

EPNS Representatives

The EPNS has appointed representatives in key organisations who play a vital role in advocating for child neurology and ensuring the Society remains well-informed about relevant developments. Their contributions are essential in maintaining the visibility of paediatric neurology across Europe and around the world.

As in previous years, in 2025 the EPNS continued to strengthen its collaborations with major neurological and child-health organisations, fostering advocacy, shared goals, and coordinated initiatives at both the European and global levels. Read on to discover more about our collaborations in 2025, along with our aspirations and plans for the future.

OneNeurology



The EPNS is a partner of OneNeurology, an initiative that unites and strengthens neurology-related groups to stimulate collaborative advocacy, action, and accountability for the prevention, treatment, and management of neurological

disorders worldwide. OneNeurology is currently focusing on the implementation of the WHO Global Action Plan for Neurological Disorders (IGAP) through its member states.



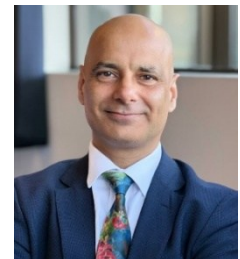
In 2025, EPNS Honorary Member and OneNeurology Vice Chair Coriene Catsman-Berrevoets represented the EPNS at the World Health Assembly (WHA) in Geneva, contributing an EPNS statement to WHA Item 13.1: *'Follow-up to the political declaration of the third high-level meeting of the General Assembly on the prevention and control of non-communicable diseases.'* At the WHA, the OneNeurology position paper, *'Ensuring Neurological Conditions are a Distinct Pillar in the NCD Response,'* was presented and discussed.



OneNeurology successfully lobbied for the reinstatement of neurology in a UN-level political document, which shapes global political and financial support and serves as a framework for regional initiatives such as those in the EU. The organisation emphasised the urgent need for action, highlighting that neurological disorders are a leading cause of both disability and premature death worldwide. These conditions impose lifelong burdens with significant societal and economic impacts, affecting patients, caregivers, and communities alike.

European Brain Council (EBC)

In 2025, the European Paediatric Neurology Society (EPNS) continued to strengthen its advocacy at the European level through active engagement with the European Brain Council (EBC). Since 2021, the EPNS has been a full member of the EBC, with EPNS Board member and past President Sameer Zuberi serving as Vice-President, ensuring that child neurology is represented within this influential European network.



The EBC is a key advocate for the prevention, early diagnosis, and treatment of brain diseases, promoting brain research as a societal priority. Through this network, the EPNS is advancing a life-course approach to brain health, from antenatal influences on brain development, through childhood and adolescence, and into later life.

EPNS participation in EBC activities in 2025 included Sameer Zuberi representing the society at the EBC 'Rare Disease Day 2025: Towards a Rare Brain Disease Ecosystem' on 20 February and endorsement of *The European Charter for the Responsible Development of Neurotechnology*—to which Sameer Zuberi contributed





On 5 March 2025 an EBC event entitled "Health & Social Benefits from Reduced Alcohol Consumption: When Less is More" was hosted by MEP Jonas Sjöstedt to discuss policies to reduce alcohol harms. After the presentation of key findings, there was a panel discussion with the EPNS kindly represented by panelist Prof. Mirjam Landgraf. There was a fruitful discussion about the impact of alcohol on brain health.

Kevin Rostasy presented the EPNS mission at this first ever International Meeting which



was hosted in Bern. Representatives from 21 national, regional and societal initiatives met under the auspices of the Swiss Brain Health Plan with the World Health Organisation (WHO) to exchange their experiences in the development of Brain and Mental Health Plans across the world.

On June 26, 2025, the EBC met with MEP Romana Jerkovic, and Ilona Kopyta, EPNS Board member. Among the issues raised, attention was drawn to the need to improve communication between basic researchers and clinicians, translating the results of basic research into application in patients.



The annual EBC Brain Innovation Days took place this year in Brussels from 14–16 October. Sameer Zuberi attended a session exploring how insights from neuroscience can guide educational practices and support healthy brain development. From the built environment to the role of parents and society, the session called for more research and collaboration between neuroscientists, educators, and policymakers to help every child

EPNS was proud when Sameer Zuberi represented the EPNS and EBC at this year's United Nations General Assembly (UNGA80) in New York. (24–26 September) Professor Zuberi participated in the Gates Foundation's prestigious Goalkeepers event and contributed to high-level discussions at the UN Headquarters on integrating brain health into the United Nations' strategy on Non-Communicable Diseases (NCDs). As part of the UNGA Brain Health Summit, he also spoke on the topic '*Brain Health Across the Lifespan*', placing a spotlight on the need to raise global awareness of Childhood Dementia.



EPNS has been involved in the EBC Coordination & Support Action on Brain Health contributing to ensure that brain health across the lifespan and child neurological disorders were integrated into future research calls within the European Partnership for Brain Health with 500m Euros funding commencing in January 2026. The EBC continues to develop its Rethinking series, with Myasthenia Gravis, NF1 and Childhood Dementia being explored.

Through these combined efforts with the EBC, the EPNS has reinforced its role as a leading advocate for paediatric neurology in Europe, driving policy, research, and collaborative initiatives to improve brain health across the life course. Many further projects are in development.

European Academy of Neurology (EAN)

In 2025, the European Paediatric Neurology Society (EPNS) continued to strengthen its collaboration with the European Academy of Neurology (EAN), which focuses on adult neurology in Europe.

The two societies operate under a Memorandum of Understanding to collaborate on guidelines, education, and research. The EPNS has representatives on nineteen EAN scientific panels relevant to child neurology, and the Presidents of both societies meet regularly to coordinate initiatives on brain health, guidelines, and the process of transition. Ongoing collaboration includes a Taskforce on transition from childhood to adulthood in Europe, led by Dana Craiu. During the EAN Congress on 23 June 2025, Kevin Rostasy met with EAN Board members, including President Elena Moro, to discuss all matters included in the MoU.



EPNS is proud to continue its collaboration with EAN as we work together toward our



shared mission: reducing the burden of neurological diseases across the lifespan. This partnership was recently demonstrated through a successful Joint EPNS/EAN webinar on 'Paediatric Arterial Ischemic Stroke: Risk Factors, Acute Management, and Prognosis', featuring expert contributions from Thomas Clement Truelsen, Julie Brix Bindslev with EPNS Board members Ilona Kopyta and Roberta Cilio. Following this well

received webinar on 7 October 2026 a further joint EPNS/EAN webinar is planned covering the topic of Functional Neurological Disorders (FND). One of the speakers will be Natalia Szejko from the EAN.

In addition, EPNS representatives attended multiple EAN Scientific Panels, including the Neuro-oncology Panel on 22 June and the Stroke Panel in June, both represented by Ilona Kopyta.

Joint sessions at the 2025 congresses further highlighted the collaboration between the societies, including at the EAN Congress, the session '*Acute demyelinating syndromes across the ages*' featured speakers Kevin Rostasy, Barbara Kornek, and Rinze Neuteboom.

At the EPNS Congress, the session '*Dyskinetic cerebral palsy: Update in management opportunities*' was chaired by Leena Haataja with invited speaker Anne Koy. EAN had an exhibition desk at the EPNS Congress in Munich 2025 and endorsed the 2025 EPNS Congress.

Through these collaborative initiatives, the EPNS has reinforced its role as a leading advocate for paediatric neurology in Europe, promoting research, education, and clinical excellence, while advancing the interface between child and adult neurology.

Building on this momentum, EPNS is thrilled that a joint EPNS/EAN session proposal covering Paediatric Stroke Across Ages has been accepted into the next EAN Congress programme, which will take place on 27-30 June 2026 in Geneva. The Chairpersons will be Ilona A. Kopyta (EPNS) and Thomas Clement Truelsen (EAN) and is now in the process of being organised.

On 23 June 2025, the EPNS was kept informed about efforts to encourage national neurological societies to lobby their respective governments in preparation for the high-level meeting on non-communicable diseases (NCDs) in New York, highlighting the society's ongoing engagement in global brain health advocacy.

European Reference Networks: ERNs

ERNs are virtual networks involving healthcare providers across Europe. They aim to facilitate discussion on complex or rare diseases and conditions that require highly specialised treatment, and concentrated knowledge and resources. The ERN initiative receives support from several EU funding programmes. The EPNS has been working closely with several related ERNs and as a result has the following Memoranda of Understanding (MoU):

- EpiCARE European Reference Network on epilepsy
- ERN-ITHACA: European Reference Network for Rare Malformation Syndromes, Intellectual and Other Neurodevelopmental Disorders
- ERN-NMD European Reference Network on neuromuscular diseases
- ERN-rita care of patients with Rare Immunological Disorders
- ERN-RND European Reference Network on neurological diseases MetabERN: European Reference Network for hereditary metabolic disorders

In addition, I am pleased to report that with support of Agnese Suppiej an MoU is in process with the ERN-EYE: European Reference Network on eye diseases. An example of the EPNS working with the ERNs is the EPNS & ERN-RND Winter School which was a virtual event held in March 2025 which was a successful, well attended collaborative event entitled 'Challenges of Treating Rare Neurological Diseases'. European Academy of Childhood Disability (EACD)

The EPNS is delighted to have a signed Memorandum of Understanding with the European Academy of Childhood Disability (EACD), cementing a longstanding and fruitful collaboration.

In 2025, this partnership was highlighted through joint sessions at both the EPNS and EACD/IAACD congresses.

At the EACD/IAACD Congress in Heidelberg in June, the EPNS participated in the joint symposium '*EACD/IAACD meets International Child Neurology*', held in collaboration with EACD, GNP, and ICNA, with speakers including Kevin Rostasy, Florian Heinen, and Sebastian Schroeder.



At the EPNS Congress, a plenary session covered *Movement Disorders and Rehabilitation*, featuring speakers Mark Hallet, Andreas Meyer-Heim, and Elegast Monbaliu.

These joint initiatives highlight the EPNS's commitment to fostering international collaboration in paediatric neurology and advancing education and clinical excellence across the field.

On 13 May 2026 there is a joint EPNS/EACD webinar planned to cover the topic of key neurological signs in chronic movement disorders of childhood with speakers Jean-Pierre Lin (EPNS) and Elegast Monbaliu (EACD), chaired by Ilona Kopyta.

The next EACD Congress will take place on 3-6 June 2026 EACD in Galway and EPNS Board members Ilona Kopyta is in consultation with Rory O'Sullivan and developing a joint EPNS/EACD session to cover the acute phase of some severe conditions such as intracranial hemorrhage, stroke, neonatal stroke, NORSE, etc. with Kathleen Gorman presenting on behalf of the EPNS.

European Academy of Paediatrics (EAP)

From 16–19 October 2025, Roberta Cilio represented the EPNS at the European Academy of Paediatrics (EAP)

Masterclass in Warsaw, presenting on '*Seizures or Non-Seizure: Diagnosis and Management.*'

In addition, the EPNS contributed to an accepted manuscript, '*Sport Activities for Children and Adolescents: Part 2. Joint Position Statement of Pediatric Societies,*' which is set to be published in *Acta Paediatrica*. These activities demonstrate EPNS's ongoing commitment to education, clinical guidance, and collaboration in paediatric neurology.



European Medicines Agency (EMA)



Since 2023, the European Paediatric Neurology Society (EPNS) has been a recognised EMA stakeholder, ensuring that child neurology is represented in the evaluation and supervision of medicines.

Several EPNS experts have been appointed as points of contact in key paediatric neurology fields, providing expert input on regulatory and therapeutic matters. In 2025, the EMA engaged the EPNS on multiple initiatives: Dimitrios Zafeiriou provided input on CHMP early dialogue with healthcare professional organisations regarding leriglitazone; Christine Makowski participated in a project on Angelman Syndrome; and Nadia Bahi-Buisson provided input on CHMP early dialogue regarding Trofinetide. These collaborations highlight EPNS's role in representing paediatric neurology expertise in regulatory decision-making and medicine evaluation at a European level.

Most recently, the EMA, in collaboration with the EPNS and other European healthcare professional and consumer organisations, launched a new awareness campaign on medicine shortages. The #ItTakesATeam campaign highlights the shared efforts to prevent and manage shortages across the EU, and the role of each actor in supporting patients faced with these shortages.

On 4 November 2025 Dimitrios Zafeiriou and Ilona Kopyta attended and represented the EPNS at the EMA public webinar on 'shortages: putting patients first'. International Presidents



The group continues to meet virtually every 6 months with the aim to collaborate and avoid duplicating activities. Two board representatives from the International Child Neurology Association (ICNA), the African Child Neurology Association (ACNA), Asian & Oceania Child Neurology Association (AOCNA), South American Child Neurology Association (AINP), North American Child Neurology Association (CNS) attends, together with the EPNS.

In line with the aims of this EPNS committee, a main focus for these meetings is the implementation of IGAP. Celebrating World Brain Day was discussed at meeting which took place in June 2025. Both EPNS, represented by Kevin Rostasy, and ICNA are currently contributing to a World Health Organisation (WHO) paper on neurorehabilitation. The most recent meeting in November 2025 focused on sharing activities of each and the plans for ICNA's next congress ICNC2026 taking place in Taipei next year. Several EPNS Board members have been invited to talk at ICNC2026, and more details will be shared next year.

In tradition of the close relationship between EPNS and ICNA, on 10 July 2025 at the EPNS Congress in Munich there was a joint EPNS/ICNA session on Neuroinfectiology / neuroimmunology

17th Asian Oceanian Congress of Child Neurology (AOCCN) Congress

EPNS was honoured to be represented at the 17th Asian Oceanian Congress of Child Neurology (AOCCN), held in New Delhi, India, from 16–20 September 2025. Prof. Kevin Rostasy, EPNS President, delivered a keynote lecture on 'MOGAD – Diagnostic and Management Consensus', contributing to this year's theme, "Innovations and Insights in Child Neurology." The congress brought together global experts to share the latest advancements and strengthen international collaboration in paediatric neurology. Our sincere thanks to the AOCCN organisers for hosting such a valuable and inspiring event.



International Paediatric Stroke Organisation (IPSO)

Our EPNS representative Ilona Kopyta launched this new collaboration later last year and on 25 March 2025 the EPNS signed a new Memorandum of Understanding (MoU). We look forward to working alongside IPSO.



International League Against Epilepsy (ILAE)

The ILAE is the world's leading association of health care professionals and scientists working toward a world where no person's life is limited by epilepsy. This year, the EPNS was delighted to sign a Memorandum of Understanding with the ILAE, and we look forward to future collaborations. There are already several joint guideline projects underway. The 15th European Epilepsy Congress took place in Rome in September 2024 which was attended by many EPNS Board members and the YEPNS manned an EPNS/YEPNS desk in the exhibition area.



Lviv, Ukraine Congress

On 6-7 June 2025, Kevin Rostasy, EPNS President was honoured to be a special guest of the Prime Paediatrics pre-congress in Lviv Ukraine, representing the EPNS covering the topic of demyelinating and autoimmune nervous system.

Endorsement process

The EPNS uses AGREE II, an instrument used by other esteemed organisations, to consistently endorse existing guidelines. Details will be uploaded here as the EPNS begins to take this forward <https://www.epns.info/epns-guideline-development-rules/> There are already several papers which are in the pipeline to undergo the EPNS endorsement process, and more details will be provided in the full year EPNS annual report for 2025.

Project on Transition in Europe

EPNS and YEPNS finalized a review paper on transition in Europe who will be sent to EJPN.

The EPNS is collaborating with the EAN within a newly created Transition Taskforce looking at transition from childhood to adulthood in Europe. Thank you to everyone who completed the recent fact-finding survey; analysis has started so the Taskforce can address the areas highlighted. A position paper is being created for all adult neurologists and child neurologists to increase awareness across all neurological conditions. This will be a common general framework on the principles of transition.

ILAE neonatal seizures treatment protocol

This guideline has been awarded EPNS endorsement using AGREEII and can be found on the EPNS Guidelines HUB.

Dystonia in Paediatric Palliative care



A collaborative project has been completed by the Paediatric Dystonia and Palliative Care Group and EPNS, represented by Jean-Pierre Lin. The guideline is now available on the EPNS Guidelines HUB.

Committee National Advisers (C N A)

The Committee of National Advisers is constituted of advisers selected by the national paediatric neurology societies and associations from European countries according to the World Health Organization (WHO) European Region definition. Normally each country is represented by one member. Currently 44 countries are represented in the CNA along with an observer from the European Academy of Neurology (EAN).

Chair C N A

The CNA is a forum for mutual information, discussion and debate on matters relevant to pediatric neurology. The CNA has an executive group consisting of its chairperson, secretary and 3 elected members. The CNA is independent of the EPNS but is intended to work in close relation with it. While the CNA is constituted of advisers selected by the national societies, the EPNS is a society of individual members. The CNA is represented on the board of the EPNS and in its Education and Training Committee by its chairperson and elected members. The EPNS is represented in the CNA by its president and other relevant persons as full members of the CNA. Established in 2022, the EPNS Advocacy and Collaboration Committee has brought new opportunities to improve this relation further.

C N A Meeting

The CNA meet biennially just before the EPNS Congress. The CNA meeting took place on 8 July 2025, before the 16th EPNS Meeting in 8-12 June, 2025 in Munich, Germany.

Following the CNA meeting in Prague, Czech Republic in 2023, it was a wonderful opportunity for the CNA representatives to gather and hear a comprehensive update about the EPNS activities, as well as comments and questions on current situation of paediatric neurology in their country. More than half of the CNA members confirmed attendance to the meeting, and 26 of the 44 representatives attended. After a welcome and introduction by Dilek Yalnizoglu, Chair, CNA Executive Committee, Kevin Rostasy, the EPNS President, provided a general update about the EPNS activities, followed by presentations by Dana Craui, Chair, Education and Training Committee and Guidelines Committee; Maja Steinlin, Chair, EPNS Exam Organising Team; Barbara Plecko, Chair, Scientific and Research Committee; Anna Jansen, Chair, Advocacy and Collaboration Committee, Jean-Pierre Lin, Chair, Website and Membership Committee.

The role of the CNA in education and training activities of the EPNS was emphasised throughout the meeting. CNA members were invited to contribute to the next EPNS Exam in 2027 in Barcelona, Spain. The EPNS Exam Organising Team will be providing continued support and guidance for preparing exam questions.

Perspectives and remarks on future CNA activities, and training issues were discussed.



Ivan Ivanov, CNA member for Bulgaria, presented the results of his project 'Survey on Neurodevelopmental Screening in Europe'. He had invited all CNA members to respond a survey on neurodevelopmental screening in Europe back in 2022. Ralitzia Yordanova presented the project as the representative for Bulgaria during the CNA meeting in 2023, in Prague, then the survey was re-sent after the EPNS Congress in 2023. During the CNA meeting in 2025, Ivan Ivanov presented the final results of the project which was also presented as a poster at the EPNS Congress, and he will be working on the project to include more European countries.

Regarding patient care, treatment challenges of rare disease and epilepsy in low and middle income countries were discussed. Regarding training, subspeciality training in paediatric neurology in Europe was discussed with special emphasis on epilepsy.

At the end of the meeting the first announcement about CNA Executive Committee election for the term 2026-2030 was made, along with summary of election process, what the roles entail and why members should consider nominating themselves.

EPNS Exam

The first EPNS Exam was held just before the 15th EPNS Meeting in 2023 in Prague, Czech Republic. The second exam was held before the 16th EPNS Meeting in Munich, Germany in 2025. I would like to note that CNA members are an integral part of the EPNS Exam Organising Team, providing questions and spreading the word about the exam across their national societies. CNA members are invited to contribute to the exam and include their local network -if they think that would be more productive. Maja Steinlin, head of the EPNS Exam Organising Team, continues to support CNA members regarding their questions and comments on preparing exam questions. In addition to classical references, the references for the exam include the EPNS syllabus, training guide with webinar/course synchronisation. The next EPNS Exam will be held before the EPNS Congress in 2027 in Barcelona, Spain. The EPNS Exam has been considered as exit exam or replacement for the written test of the current exit exam by some of the national societies. Therefore it was suggested to hold the EPNS Exam annually going forward, this will be further discussed and clarified after the third EPNS Exam in 2027 in Barcelona.

EPNS Syllabus

This EPNS syllabus describes the European training programme in paediatric neurology. It is regularly reviewed and updated. The first version of the document was approved in November 2002 by The European Paediatric Neurology Society and by the European Committee of National Advisers (comprised of representatives of National Paediatric Neurology Societies in Europe) and by the Sections of Paediatrics and of Neurology of



the Union of European Medical Specialists in December 2002 and March 2003 respectively. The first revision dates from January 5th 2009 and was approved by Sections of Paediatrics and of Neurology of the Union of Medical Specialists in November 2010. Subsequently, European Paediatric Neurology Training Programme Concept Version was approved by the General Board of the EPNS on March 9th, 2019 and by the EPNS Committee of National Advisers on September 17th, 2019. In the face of rapidly expanding knowledge in child neurology, an update on the EPNS syllabus is expected during the next term. Principles regarding subspeciality training in paediatric neurology were suggested to be taken in consideration during preparation of the updated version. These aspects were discussed during the recent EPNS Board Meeting in 31 October-1 November 2025, in Leuven, Belgium.

EPNS IGAP Initiative

In 2021, WHO published a discussion paper; *Intersectoral Global Action Plan (IGAP) on Epilepsy and Other Neurological Disorders 2022-2031*. Following a period of consultations and revisions, IGAP was adopted unanimously at World Health Assembly in 2022.

In 2024, the EPNS started an initiative regarding IGAP. The EPNS vision is to ensure IGAP is implemented in each European country with the voice of child neurology heard. This has been an ongoing project led by Kevin Rostasy, EPNS President and Anna Jansen, Chair EPNS Advocacy and Collaboration Committee, in collaboration with WHO and relevant international societies. Training Advisory Board (TAB)

In 2002 Paediatric Neurology was accepted at the European level as a sub-specialty of Paediatrics and of Neurology. In the process of defining the specialty, a European Paediatric Neurology Training Programme (Syllabus) was compiled, further information can be found here

In order to push the implementation of a high standard of paediatric neurology training, in 2004 the EPNS Board and the Committee of National Advisors (CNA) agreed to create a Training Advisory Board (TAB) and to develop a training evaluation programme intended to support national societies in developing their training systems. TAB offers the national child neurology societies the opportunity to evaluate their national training system. The aim is a standard of training in accordance with the European Paediatric Neurology Training Programme (Syllabus) in each European country. The assessment is voluntary and initiated by the national paediatric neurology society, relevant information can be found here <https://www.epns.info/about-epns/tab/>

So far the training system was evaluated in 13 countries. The most recent TAB visit was hosted by Spanish Paediatric Neurology Society (SENEP), Spain, in 27-28 October 2025. Kevin Rostasy, EPNS President, Dana Craiu, Chair, Education and Training Committee, Dilek Yalnizoglu, Chair CNA and TAB completed the TAB visit, and an evaluation report is in preparation. Of note, Spain is the first and the only country with an EPNS TAB re-visit more than 10 years apart.

I am delighted to announce that CNA-TAB has received an invitation from Greece in September 2025, and a TAB visit to Greece is currently in preparation.

I would strongly encourage national societies to consider an EPNS TAB visit. In addition, I suggest that national societies of the countries who had been visited in the past may consider if they will benefit from an update visit and assess their progress and accomplishments after the first evaluation. In the mean time, reminder letters to CNA members will be sent periodically.

YEPNS is represented by a Committee, currently composed by 23 members, representing 14 European countries.

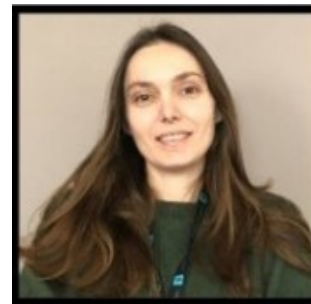

The new YEPNS Chair will serve a minimum term of two years.

The procedures and modalities of the YEPNS elections were conducted in accordance with the YEPNS Memorandum, which was created and approved by all Committee members and the EPNS Board in May 2025 (available at: <https://www.epns.info/wp-content/uploads/2025/05/YEPNS-Committee-Memorandum-V-2.0.01.05.2025.MP.pdf>).

The European Journal of Paediatric Neurology (EJPN) is the official journal of the EPNS and is available to all members in either electronic or print & electronic format. Published 6 times a year by Elsevier Ltd. on behalf of the society it accepts high-quality papers primarily of a clinical research nature on the whole spectrum of paediatric neurological disease, as well as consensus statements and expert guidelines on current interesting issues and controversies. The journal is owned by the society and contributes to the income of the EPNS through royalty payments.

With an Impact Factor of 2.3, the number and quality of submissions remains high, despite the difficulties posed by and after the pandemic. A new special issues on New Advances in Neurometabolic Diseases was just published and a second one on New Advances in Childhood Stroke) is currently on the way, with many world-leading basic and clinical neuroscientists contributing articles. For 2026 two new special issues are planned: Advances in Neurocritical Care in Children and New Complex Therapies ,Chances, Challenges & Missing Structures.

In accordance with the educational nature of EPNS, the Editorial team has continued to publish high-quality “Teaching Papers” on specific topics presented in the EPNS monthly Webinars.

EJPN’s Editorial Team together with the EPNS Board awarded for the second time the “EJPN Paper of the Year” award (original paper), which was presented during the Opening Ceremony of the Biennial EPNS Congress in Munich (July 2025) and accompanied by a money prize and free registration to the Congress. The next “EJPN Paper of the Year” will be awarded during EPNS Congress in Barcelona (April 2027). The journal has a distinguished and recently renewed international Editorial Board of specialists who advise on the direction of the journal, special issues, and review papers, superbly moderated by four Associated Editors, Kathleen Gorman, Lucia Gerstl, Anne Jansen and Ming Lim and who are world-renowned experts in their field.

A little more information about

The European Paediatric Neurology Society (EPNS)

Honorary membership is for persons who the society wishes to honour for outstanding distinction in the field of paediatric neurology.

Associate membership is awarded, on application, to all paediatric neurologists and colleagues in related fields and that belong to their national society or association in their field and to any physician, basic scientist or clinical scientist trainees in paediatric neurology who shows an interest in the neurology of infancy, childhood, or adolescence, whether in research or in clinical medical care. There are no geographical restrictions to associate membership. Associate members pay an annual subscription, which includes subscription to the European Journal of Paediatric Neurology, the Journal of the Society.

Ordinary membership is for any associate member that is also in practice in Europe (currently taken as the region for which European Office of WHO is responsible). Transition from associate to ordinary membership takes place by the vote of the general assembly at the meeting of The Society. The only difference between associate and ordinary membership is the entitlement of ordinary members to vote for and stand as candidates for election to the Board of the Society.

EPNS Membership Fees for 2026

EPNS membership fees (also known as subscription fees) are payable each year and cover the period 1 January until 31 December.
